1. The Inaruwa Municipality, Inaruwa, Sunsari invites sealed bids from eligible Nepalese bidders for the construction of **Office Building of Inaruwa Municipality at Inaruwa, Sunsari in multiyear contract basis.**
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Inaruwa Municipality, Inaruwa, Sunsari during office hours or may visit E-procurement section of PPMO's Web portal <http://www.bolpatra.gov.np>.
3. A complete set of bidding documents in English may be purchased by the interested bidders upon submission of a written application attaching copies of the Bidders Registration, VAT Registration and Tax Clearance certificates of F/Y 071/72 at Inaruwa Municipality, Inaruwa, Sunsari and upon payment of a non-refundable fee of NRs. 3000.00 (Nepalese rupees three thousand only) Bidding documents can be purchased within the office hours on or before falgun 18, 2072 (2016/03/01)

For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of PPMO's Web portal <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document NRs. 3000.00 (non - refundable) in the Municipality's Rajaswa (revenue) account no either by direct deposit or by tele-transfer of deposit in the Municipality Office account for the purchase the bids as specified below and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele-transfer certificate shall also be submitted along with the electronic bid files.


4. Sealed Bids must be delivered to the **Inaruwa Municipality, Inaruwa, Sunsari** on or before 12:00 hrs of falgun 19, 2072 (2016/03/02). Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web portal <http://www.bolpatra.gov.np> as specified in the Instruction to Bidders on or before 12:00 hrs of falgun 19, 2072 (2016/03/02). Late bids will be rejected. Bids will be opened physically and electronically at 14:00 hours on the same day of bid submission in the presence of the bidders or their representatives who choose to attend.
5. Pre-bid meeting will be held in the Inaruwa Municipality, Inaruwa, Sunsari at 14.00 hrs on 2072/11/06. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.
6. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of as described in details of work and issued by commercial bank, which shall be valid for **30 days** beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day. In such a case the validity of bid security shall be considered from already specified last date for bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. Bidders Annual Turnover and Experience requirement are:

10.1 Average Annual Turnover of the construction work of best 3 years over the last 5 years is: **NRs. 50.00 Million** (including VAT)

10.2 Minimum work experience of similar nature in the last 10 years is: two number single RCC frame structure building and value not less than **NRs. 22.00 Million** or one number single RCC frame structure building and value not less than **NRs. 30.00 Million** (including VAT).
